

November 5, 2019 General Election

Issues

As of 08/08/19

- Bellevue Public Library (Erie, Huron, Sandusky & Seneca Counties)

1 mill renewal for current expenses, amounts to ten cents (\$0.10) for each one hundred dollars of valuation, continuing period of time commencing in 2020, first due in 2021

Bellevue 1-A, 1-B, 2-A, 2-B, York A(BE), York B(BE)

- Clyde D – Local Liquor Option – El Habaneros Mexican Restaurant – Sunday sales 11 am – midnight

Clyde D

- Sandusky County Health District

0.5 mill renewal for necessary expenses, amounts to \$0.05 for each one hundred dollars of valuation 5 years, commencing in 2019, first due in 2020

Countywide (all precincts except Bellevue City)

- Madison Township

1.0 mill renewal for maintaining and operating cemeteries, amounts to \$0.10 for each one hundred dollars of valuation for 5 years, commencing in 2020, first due in 2021

Madison Township, Gibsonburg A, Gibsonburg B

- Townsend Township

2.0 mill replacement for fire protection, amounts to \$0.20 for each one hundred dollars of valuation for 5 years, commencing in 2019, first due in 2020.

Townsend Township

- Helena Village (2) **This levy will appear on ballot twice. Two different levies asking for the same thing.

3.0 mill renewal for current expenses, amounts to \$0.30 for each one hundred dollars of valuation for 5 years, commencing in 2019, first due in 2020.

Helena Village

- Ballville Township

1.25 mills renewal for general construction, reconstruction, resurfacing and repair of streets, roads and bridges, amounts to \$0.125 for each one hundred dollars of valuation, for 5 years, commencing in 2020, first due in calendar year 2021.

Ballville A, Ballville B, Ballville C, Ballville D, Ballville E, Ballville F, Ballville G

- Clyde-Green Springs Schools

4.2 mills additional to avoid an operating deficit in the school district, amounts to .42¢ for each one hundred dollars of valuation, for 5 years, commencing in 2019, first due in 2020.

Clyde A thru Clyde E, Ballville A (CV), Ballville E (CV), Green Springs, Green Creek A, Green Creek B, Green Creek C (CV), Green Creek D, Riley (CV), Townsend (CV), York A (CV), York B (CV)

- Rice Township

A replacement of .09 mills and an increase of 1.1 mills for fire protection, amounts to .20¢ for each one hundred dollars of valuation, for 5 years, commencing in 2020, first due in 2021.

Rice

- Washington Township

A renewal of 1.5 mills and an increase of .95 mills for fire protection, amounts to .245¢ for each one hundred dollars of valuation, for 5 years, commencing in 2020, first due in 2021.
